



## Privacy Notice

Facts	What does Educational Systems Federal Credit Union do with your personal information?
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>■ Social Security Number</li> <li>■ Account Transactions</li> <li>■ Income</li> <li>■ Credit History</li> <li>■ Employment Information</li> <li>■ Assets</li> </ul> <p>When you are no longer our member, we continue to share your information as described in this notice.</p>
<b>How?</b>	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons Educational Systems FCU chooses to share; and whether you can limit this sharing.

<b>For our everyday business purposes—</b> such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus	Yes	No

<b>What we do</b>	
How does Educational Systems FCU protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  Educational Systems FCU regularly tests and assesses its information security measures, trains employees and adapts upgrades and enhancements as necessary to protect your information.
How does Educational Systems FCU collect my personal information?	We collect your personal information, for example, when you do the following: <ul style="list-style-type: none"> <li>■ Open an account</li> <li>■ Provide employment information</li> <li>■ Pay your bills</li> <li>■ Use your credit or debit card</li> <li>■ Apply for a loan</li> </ul> We also collect your personal information from others, such as the Credit Bureaus and other affiliates and companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only the following: <ul style="list-style-type: none"> <li>■ Sharing for affiliates' everyday business purposes— information about your creditworthiness</li> <li>■ Affiliates from using your information to market to you</li> <li>■ Sharing for non-affiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
<b>Definitions</b>	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>■ <i>Support Education Foundation, Inc.</i></li> </ul>
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>■ <i>Educational Systems FCU does not share with non-affiliates to market to members except under a joint marketing agreement with the Credit Union.</i></li> </ul>
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>■ <i>Our joint marketing partners we share with can include insurance, investment and other financial services.</i></li> </ul>

### Other important information

Educational Systems FCU is committed to protecting the privacy of its members. To protect our members' privacy, we only work with companies that agree to maintain strong confidentiality and limits the information we provide. We do not permit companies to sell the information we provide to other third parties.

If you believe we have made an error on your consumer credit report, notify us in writing immediately explaining the error.
